Explanations

<u>Luminaires - Product codes E4/26, E4/27, E4/28, E5/17, E5/18 and E5/19</u> On these product codes for luminaires, no distinction based on size applies, but on weight (>750 grams or ≤750 grams).

Lamps - Product code E3/04

Due to rising costs and phasing out of fluorescent and energy saving lamps, the rate for Led lamps has increased slightly. The rates have been calculated in such a way that they will remain stable in the coming years.

Solar Panels - Product code E4/32

The producer is kindly requested to state the waste management fee for solar panels (€ 0.04/kg) separately on the invoice.

ICT - Product codes E2/02, E2/03, E2/04, E4/24, E4/25, E6/01, E6/02, E6/03, E6/04 and E6/05 The costs for increased collection, safe transport, sorting and high-quality processing are rising, while raw materials yields are decreasing. Due to lower put on market volumes of ICT, the net costs are divided by a smaller number of kilos. Here the rate per kilo increases.

Large household appliances - Product codes E1/01, E1/02, E1/03, E4/01, E4/02, E4/03, E4/04, E4/05, E4/06, E4/07, E4/08, E4/09, E4/11, E4/014

The costs for collection, logistics and sorting have increased in recent years, while raw material yields show a slightly decreasing trend. This increases the costs per kilogram. The fees for 2024 have not increased because there are sufficient surpluses to cover the increase in costs. A fee increase is expected to be implemented from 2025 because the surpluses will then be fully utilized.

From 2025, the aim will be for rates that remain stable for a number of years for all product codes

Small household appliances - Product codes E5/01, E5/02, E5/03, E5/04, E5/08

The fees for 2024 will decrease due to discounting of available surpluses. It is expected that the new lower fee will be maintained in 2025. From 2025 onwards, the aim will be stable fees for a number of years for all product codes.
